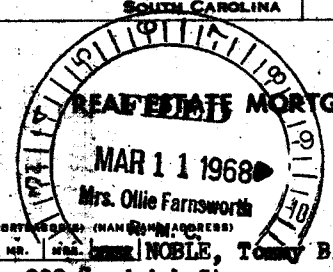

BEGINNING at an iron pin on the south side of Goodrich St., joint corner of Lots # 67 & 68 running thence along the line of Lot # 69, 36-15 W. 142.2 ft; thence N. 59-23 W. 75.35 ft. thence along the line of Lot # 67, N. 36-15.3 135.1 ft. to Goodrich St.; thence along the South side of Goodrich St., S. 64-49 E. 76.4 ft. to an iron pin at the point of beginning.

To have and to hold, with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, unto said Mortgagee, provided always, and this instrument is made, executed, sealed and delivered upon the express condition that if the said Mortgagors shall pay in full to the said Mortgagee the above-described Note according to the terms thereof, then this Mortgage shall cease, determine and be void, otherwise it shall remain in full force and virtue.
