

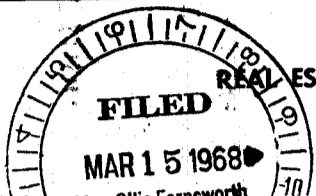

BEGINNING at a point on the South side of Apopka Avenue, joint corner Nos 43 and 44 and running thence S 33-54W, 150 feet; thence N56-06 W. 50 feet to joint rear of Lots Nos 43 and 42; thence N.33-54E, 150 feet to a point on Apopka Avenue; thence with apopka Ave 50 feet to the point of beginning.

To have and to hold, with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, unto said Mortgagee, provided always, and this instrument is made, executed, sealed and delivered upon the express condition that if the said Mortgagors shall pay in full to the said Mortgagee the above-described Note according to the terms thereof, then this Mortgage shall cease, determine and be void, otherwise it shall remain in full force and virtue.
