(hereinafter referred to as Mortgagor) SEND(S) GREETING:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the North side of Milford Drive, near Milford Baptist Church, Oneal Township, and being known and designated as lots Nos. Four (4), Five (5), Six (6), Seven (7), Eight (8) and Nine (9) of the W. Dennis Smith property as shown on plat prepared for W. Dennis Smith by H. S. Brockman and John A. Simmons, Registered Surveyors, dated Aug. 15, 1959 and which plat has been recorded in the R. M. C. Office for said county in Plat Book TT, page 17. This being a part of the property which was conveyed to W. Dennis Smith by Nathan F. Clayton and Viola S. Clayton by deed recorded in said office in Deed Book 626, page 415.
