WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Twenty-Five Thousand One Hundred and No/100ths** ----- DOLLARS (\$ 25,100.00), with interest thereon from date at the rate of **six and three-fourths** per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Northern side of Hillsborough Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 42 as shown on a plat of Merrifield Park, prepared by C. O. Riddle, dated October 1967, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 000 at page 177 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Hillsborough Drive at the joint front corner of Lots Nos. 41 and 42 and running thence with the line of Lot No. 41 N. 19-00 E. 180 feet to an iron pin in the rear line of Lot No. 29; thence with the rear lines of Lots Nos. 29 and 28 S. 71-00 E. 110 feet to an iron pin at the joint rear corner of Lots Nos. 42 and 43; thence with the line of Lot No. 43 S. 19-00 W. 180 feet to an iron pin on the Northern side of Hillsborough Drive; thence with the Northern side of Hillsborough Drive N. 71-00 W. 110 feet to the point of beginning.
