(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto **James A. Harris, Sr.**

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of -----

Eight Thousand Four Hundred and no/100-----DOLLARS (\$ 8,400.00), with interest thereon from date at the rate of **7%** per centum per annum, said principal and interest to be repaid: **On or before ninety (90) days from date.**

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **on the northwestern side of Paris Mountain Road and having the following metes and bounds to wit:**

BEGINNING at an iron pin on the northwestern side of Paris Mountain Road and running thence N. 39-39 W., 91.5 feet to an iron pin; thence S. 45-13 W., 31.7 feet to an iron pin; thence N. 59-08 W., 61.2 feet to an iron pin; thence with the rear line of said lot, N. 51-30 E. 117.9 feet to an iron pin; thence S. 58-58 E. 36.4 feet to an iron pin; thence S. 40-45 E. 110 feet to a point on the northwestern side of Paris Mountain Road; thence with said Road S. 52-30 W. 66 feet to point of beginning. See County Block Book P39-1-6.1.
