"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

Greenville, in the Piedmont Manufacturing Company

Village, in or near the Town of Piedmont, Greenville County, South Carolina,
