WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Nine Thousand and No/100ths** -----

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Eastern side of Ridgeway Drive near the City of Greenville, County of Greenville, State of South Carolina, being a portion of the property of Parie Lee Green as shown on a plat thereof prepared by Piedmont Engineering Service, dated June 1, 1951, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book KK at page 147 and being known and designated as Lot No. 4 as shown on a plat prepared by Piedmont Engineering Service, dated February 28, 1957, revised April 10, 1958, entitled "Subdivision for Walter Griffin, et al." and having according to the last mentioned plat the following metes and bounds:

BEGINNING at an iron pin on the Eastern side of Ridgeway Drive 1,280 feet, more or less, in a Southerly direction from the right of way of the C. & W. C. Railway at the joint front corner of Lots Nos. 4 and 5 and running thence with the line of Lot No. 5 S. 75-17 E. 140 feet to an iron pin; thence S. 14-43 W. 70 feet to an iron pin at the joint rear corner of Lots Nos. 3 and 4; thence with the line of Lot No. 3 N. 73-17 W. 140 feet to an iron pin on the Eastern side of Ridgeway Drive; thence with the Eastern side of Ridgeway Drive N. 14-43 E. 70 feet to the point of beginning.
