I, J. Wallace Smith hereinafter called

NOW KNOW ALL MEN, That the said Mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor(s) paid by the said Mortgagee at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Mortgagee,

All that piece, parcel or lot of land in C. lick Springs Township, Greenville County, State of South Carolina, in the C. ty of Greer, on North Main Street (formerly Mostella Road) on the east side thereof and having the following metes and bounds, to wit:

BEGINNING at an iron pin, Miss Sallie Wilson corner and running thence S. 82-20 E., 200 feet to an iron pin; thence N. 8-45 W., 80 feet to an iron pin; thence N. 82-20 W., 200 feet to an iron pin on the east bank of North Main Street; thence S. 8-45 E., 80 feet to the beginning corner and containing 0.36 of an acre more or less. This is the same conveyed to E.S. Bell by N.E. Bright by deed recorded in the deed book 71 at page 422, subject however to the right of way of North Main Street.
