To All Whom These Presents May Concern: We, Glenn W. Knighton and Nellie M. Knighton, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the east side of Suber Road and the north side of the Chick Springs Road (Old Greenville-Spartanburg Road), about two miles westward from the City of Greer, and being Lots Nos. 51 and 52 of the T. W. Dill Estate according to survey and plat by S. C. Moon, Surveyor, dated October, 1940, recorded in Plat Book L, page 31, R.M.C. Office for Greenville County.
