THE FOLLOWING DESCRIBED PROPE TY BEING SITUATED IN THE COUNTY OF GREENVILLE, STATE OF SOUTH CAROLINA:

Beginning at a point in or near the center of a Road, this being the joint corner of Tracts Numbers 1, 2, 2, and 5, and running thence along the line of tract Number 2, South 18-45 West 0-83 to corner of Tract Number 3; thence along the boundary of Tract Number 3, and along the center of another Road, South 56-30 West 7.62 to a point; thence North 10-15 West 2.15 to a point; thence North 53-30 West 12.84 to an iron pin; thence North 27-00 West 11.53 to a point; thence North 10-30 West 4-85 to an oak; thence South 54-25 East 32-45 to the point of beginning.
