WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, located about one mile west of Washington Baptist Church, lying on State Highway No. 135, having the following courses and distances, to-wit:

BEGINNING at an old iron pin corner, and runs thence N. 48-29 W. 281.9 feet to old iron pin in Highway No. 135; thence with said highway, N. 41-31 E. 187.6 feet to a nail; thence with said highway, N. 39-05 E. 100 feet to a nail (iron pin at 20 feet on bank.); thence leaving said highway, S. 53-12 E. 224 feet to an iron pin; thence S. 29-50 W. 311.9 feet to the beginning, containing 1.70 acres, more or less, per survey and plat by J. Q. Bruce, dated May 22, 1961, and being all of that property conveyed to the mortgagors herein by Frank Lindsey and Annie A. Lindsey by deed recorded in Deed Book 677, page 52, R.M.C. Office for Greenville County.

There is excluded from the above described property .56 acre, more or less, conveyed by the Mortgagors herein to Ruhama C. Fuller, by deed dated April 20, 1967, and recorded in the R.M.C. Office for Greenville County in Deed Book 820, Page 387.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
