WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Heathwood Drive being shown as Lot 88 on plat of Heathwood recorded in Plat Book KK at page 35 in the RMC Office for Greenville County, and having according to said plat the following metes and bounds:

Beginning at an iron pin on the southern side of Heathwood Drive and running thence S 19-24 W 200 feet to an iron pin; thence S 70-36 E 90 feet to an iron pin; thence N 19-07 E 200 feet to an iron pin on the southern side of Heathwood Drive; thence with the southern side of said Drive, N 70-36 W 97 feet to the beginning corner.

Being the same property conveyed to the mortgagors by Deed Book 847 at page 428.
