STATE OF SOUTH CAROLINA : RELEASE FROM A LIEN OF
: REAL ESTATE MORTGAGE

For valuable considerations, the undersigned Fidelity Federal Savings and Loan Association, of Greenville, South Carolina, the owner and holder of that real estate mortgage, and note secured, given to it by Piedmont Park Methodist Church, dated December 11, 1958, recorded in the R.M.C. Office for Greenville County in Mortgage Book 769, at page 180, does hereby forever release and discharge from the lien of its said mortgage the following described real estate:

All of those parcels or lots of land in Chick Springs Township, of Greenville County, South Carolina, lying in the intersection of the old Rutherford Road, sometimes known as the Mountain Creek Road, and Cason Avenue, and having the following courses and distances:

BEGINNING at an iron pin, corner of the old Rutherford Road and Cason Avenue, and runs thence with the margin of the old Rutherford Road 229.5 feet to an iron pin at corner of lot now or formerly owned by A.M. Doggett; thence S. 66 1/2 E. 107 feet to an iron pin on Cason Avenue; thence with margin of Cason Avenue, S. 49 W. 242 feet to the point of beginning, and being the identical property described in deed from the Trustees of Monaghan Methodist Church to the Trustees of Piedmont Park Methodist Church, recorded in Volume 380, at page 129.

In all other respects the lien of said real estate mortgage remains intact, unimpaired, and in full force and effect.
