MORTGAGE OF REAL ESTATE

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, MIRCHARDER AND ASSIGNS FOREVER:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Gantt Township, , containing 50 and 1/4 acres, more or less, as shown on plat made by C. M. Furman Jr., Emgineer, dated January 16, 1923, and recorded in the R. M. C. Office for Greenville, County in Plat Book B at page 121 and having the following metes and bounds, to-wit:

BEGINNING at a persimmon tree in line of property now or formerly of Boniface, and running thence S. 11 W. 16.80 chains to a stone; thence N. 75 1/2 E. 5.12 chains to a stone; thence N. 71 1/2 E. 20.16 chains to a stone; thence N. 6 1/2 E. 11.70 chains to a stake on road; thence along said road 18 chains to the beginning corner, LESS HOWEVER Lots Nos. 1, 2, 3, 4, 5, 6, 7, 8, 9 and 10 and 11 as shown on plat of Property of Gus Kondros prepared by Dalton and Neves in April, 1956, with addition in August 1957 and which plat is recorded in the R.
