TO ALL WHOM THESE PRESENTS MAY CONCERN: Allied Textile Sales, Inc.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, ON THE Northern side of Oil Mill Road and the Southern side of Pendleton Road near the city of Greenville and according to a plat of property of Allied Textile Sales, Inc. made by Carolina Engineering & Survey Company made May 25, 1968 is descibed as follows:

BEGINNING at an iron pin on the Northern side of Oil Mill Road and running thence with the Northern side of said road S. 75-38 W. 178 feet to an iron pin at the corner of property of J. C. Goodwin; thence with the line of said property N. 21-06 W. 126.7 feet to an iron pin in the line of Jones' property; thence with the line of said property S. 56-00 E. 129.2 feet to an iron pin; thence continuing with the line of said property N. 34-00 E. 235.5 feet to an iron pin on Pendleton Road; thence with the Southwestern side of said road S. 56-00 E. 142.7 feet to an iron pin which is 212.5 feet northwest from Oil Mill Road; thence S. 34-00 W. 203.7 feet to the beginning corner being the same property conveyed to the Mortgagor be J. C. Goodwin by deed recorded in Deed Book 839 at Page 488 and by Vera Cox Baily by deed recorded in Deed Book 839 at Page 389 and by deed of H. J. Martin, Jr. recorded within.
