TO ALL WHOM THESE PRESENTS MAY CONCERN:

IN THE STATE AFORESAID, hereinafter called Mortgagor, JIM D. THOMAS

The word Mortgagor shall include one or more persons or corporations. The word Association shall mean the PALMETTO SAVINGS AND LOAN ASSOCIATION OF LAURENS.

WHEREAS, the said Mortgagor by his certain promissory note, in writing of even date herewith, the terms of which are incorporated herein by reference, is well and truly indebted unto PALMETTO SAVINGS AND LOAN ASSOCIATION OF LAURENS, a corporation, in the principal sum of TWENTY THOUSAND and no/100\*\*\*\*\*

(\$ 20,000.00) Dollars, with interest from the 12 day of September, 1968, at the rate of seven (7%) per centum per annum until paid. The said principal and interest shall be payable at the office of the Association in monthly installments of ONE HUNDRED FIFTY FIVE and 06/100\*\*\*\*\*

(\$ 155.06) Dollars, commencing on the 10 day of October, 1968, and on the first day of each month thereafter until the principal and interest are paid. Unpaid interest to bear interest thereafter at the same rate. And with interest from the date of said note, and this mortgage securing the same at the same rate until the date of the payment of the first monthly installment. Said monthly payments shall be applied:

- FIRST: To the payment of interest due on said loan, computed monthly.
- SECOND: To the payment, at the option of said Association, of such taxes, assessments, or insurance as may be in default on the property pledged to secure this obligation.
- THIRD: The balance of said amount to the payment to that extent, as credit of that date on the principal of this loan. Said payments to continue until principal and interest are paid in full.

Said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of ninety (90) days or failure to comply with any of the By-Laws of said Association or any of the stipulations of this mortgage, the whole amount due under said note shall, at the option of the holder hereof, become immediately due and payable, and suit may be brought to foreclose this mortgage.

Said note further providing for a ten (10%) per centum attorney's fee besides all costs and expenses of collection to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured by this mortgage), as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, that the Mortgagor, in consideration of the said debt for better securing the payment thereof to the said PALMETTO SAVINGS AND LOAN ASSOCIATION OF LAURENS, according to the conditions of said note; and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the PALMETTO SAVINGS AND LOAN ASSOCIATION OF LAURENS, at and before the sealing and delivery of these presents, the receipt of which is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the PALMETTO SAVINGS AND LOAN ASSOCIATION OF LAURENS, its successors and assigns:

All that piece, parcel or tract of land lying and being situate on the easterly side of Pruitt Drive Extension near the Town of Mauldin, in Greenville County, South Carolina, being known and designated as Lot No. 20 on plat of Green Lake Acres Subdivision prepared by H. C. Clarkson, Jr., R.L.S., dated July 23, 1965 as revised through December, 1965 as recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book JJJ at Page 115 and having according to said plat the following metes and bounds to wit:

BEGINNING at an iron pin on the easterly side of Pruitt Drive Extension at joint front corner of Lots 19 and 20 and running thence along the joint line of the said lots N.75-35 E. 661.7 feet to an old iron pin at joint rear corner of the said lots; thence S.54-53 W. 877 feet to an iron pin on the southerly boundary of Green Lake Acres; thence N. 36-00 W. 21.2 feet to an iron pin on the easterly side of Pruitt Drive Extension; thence along said Pruitt Drive Extension on an angle, the chord of which is N. 22-59 E. 109.3 feet to an iron pin; thence further along said Pruitt Drive Extension N. 14-34 E.153 feet to an iron pin; thence further along said Pruitt Drive Extension on an angle, the chord of which is N. 7-05 E. 75 feet to an iron pin at joint front corner of lots 19 and 20. the point of beginning.
