TO ALL WHOM THESE PRESENTS MAY CONCERN: I, W. Dennis Smith

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the north side of James Street in the City of Greer, Chick Springs Township, being shown as lot no. Twelve (12) of the property of Mrs. E. A. Wood Estate on plat made by H. S. Brockman, Surveyor, dated June 22, 1935, which plat has been recorded in the R. M. C. Office for said County in Plat Book FF, page 196, and having the following courses and distances, to-wit: Beginning at an iron pin on the north side of James Street, corner of lots nos. 11 and 12, and running thence along the line of said lots N.14-03 W.163.5 feet to an iron pin; thence along the rear line of lot no. 13 S.76-00 W.70 feet to an iron pin, corner of lot no. 16; thence along the line of lot no. 15 S.14-03 E.162.4 feet to an iron pin on the north side of James Street; thence along said street N.77-00 E.70 feet to the beginning corner. This being the same property which was conveyed to Bessie R. Burgess by Sidney M. Sloan by deed recorded in the said office in Deed Book 317, page 85.
