WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of -----

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of **Summitt Avenue**, being shown as a portion of Lot 15 on plat of Property of **Knox L. Haynsworth, Trustee**, recorded in Plat Book L at page 177, and having according to said plat the following metes and bounds:

Beginning at an iron pin on the southern side of **Summitt Avenue** at corner of Lot 16 and running thence with line of said lot, S 34-0 W 150 feet to an iron pin; thence N 58-58 W 50 feet to an iron pin; thence N 34-0 E 150 feet to an iron pin on the southern side of **Summitt Avenue**; thence along the southern side of **Summitt Avenue**, S 58-58 E 50 feet to the beginning corner.
