~~that~~ ^{those two} certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on southern side of Morgan Street and formerly O'Neal Avenue, being shown and designated as Lots 3 and 4 on plat of White City View recorded in Plat Book E at page 160 and described as follows:

BEGINNING at an iron pin on the southern side of Morgan Street at the joint front corner of Lots 2 and 3 and running thence with the line of Lot 2, S. 0-11 W. 150 feet to an iron pin; thence N.79-43 E. 108 feet to an iron pin at the rear corner of Lot 5; thence with the line of Lot 5, N. 0-20 W. 150 feet to pin on Morgan Street; thence with the southern side of Morgan Street, S. 79-43 W. 107.6 feet to the point of beginning.
