NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

All that certain piece, parcel on lot of land situate, lying and being on the South side of Long Hill Street, in the city of Greenville, being known as lot 88 on plat of Augusta Road Hills, made by Dalton & Neves, December 1940, recorded in the R. M. C. Office of Greenville County, S. C. in plat Book M.-Page 33 and also being shown on a more recent plat of property of M. L. Thomas and R. K. Campbell, RLS, dated October 27, 1956, and having according to both plats, the following metes and bounds, to wit; BEGINNING at an iron pin on the South Side of Long Hill Street at the joint from corner of Lots 87 and 88 and running thence with the line of Lot 87, A 2-56 W 165 feet to an iron pin; thence S.89-20 W 60.1 feet to an iron pin; thence along the line of Lot 89, N. 2-56 E. 168.8 Feet to an iron pin on the South side of Long Hill Street; thence along the South Side of Long Hill Street, S. 87-04 E 60 feet to the beginning corner.
