TO ALL WHOM THESE PRESENTS MAY CONCERN: I, John R. Mitchell,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto HOME BUILDING & LOAN ASSOCIATION, Easley, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Four Thousand Four Hundred Forty Nine and 70/100's -----

DOLLARS (\$ 4,449.70 ), with interest thereon from date at the rate of seven (7%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of ~~Dickens~~, Greenville,

in Grove Township, containing two and one-tenth (2.1) acres, more or less, adjoining lands of W. O. Turner, lands formerly belonging to W.P. Nesbitt, and possibly others, having the following courses and distances, to-wit: BEGINNING at a point in the Moonville Road at corner of W. O. Turner and running thence along line of W. O. Turner North 67 1/2 West 8.00 chains to a poplar; thence S 21 1/2 W 2.25 to an iron pin, new corner; thence S 57 E 6.87 to a point in Moonville Road; thence along said road N 42 1/2 E 3.65 to BEGINNING corner; being the identical property conveyed to John R.
