WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Fourteen Thousand Five Hundred and No/100ths--**

**14,500.00** DOLLARS (\$ 14,500.00), with interest thereon from date at the rate of **Seven** per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, containing **5.02 acres, more or less in Bates Township as shown on plat of Carlos L. Poole, recorded in Plat Book VVV, page 105 and having, according to said plat, the following metes and bounds, to-wit:**

**BEGINNING at an iron pin at the center of Kelly Mill Road at the corner of Wigington and running thence along the center of said road, N 79-55 W 495 feet to an iron pin; thence along the center of a county road N 17-30 E 445.7 feet to an iron pin; thence S 79-55 E 495 feet; thence S 17-30 W 445.5 feet to the point of beginning and being same conveyed to us in Deed Book 832, page 340.**
