All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Southeastern side of New Dunham Bridge Road near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 1 as shown on plat of Vardry-Vale, Section One, prepared by Campbell & Clarkson, Surveyors, Inc., dated November 15, 1968, and recorded in the R.M.C.
