"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that lot of land, situate, on the northeast side of Rock Hill Road, near the city of Greenville, in Greenville County, State of South Carolina, being known as lot No., 22 on plat of Dreher Colony made by R. K. Campbell Surveyor January 1964, recorded in the R. M. C. office for Greenville County, S. C. in plat book FFF at page 41; said lot having such metes and bounds as shown thereon.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
