(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FOUNTAIN INN FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **Twenty Thousand and 00/100** - - - - -

DOLLARS (\$ **20,000.00**), with interest thereon from date at the rate of **Seven (7%)** per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **GREENVILLE**, near the **Town of Mauldin**, shown as Lot 4 on a plat of Lakewood Subdivision, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book BBB, Page 181, and has, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeastern side of Evergreen Circle, at the joint front corner of lots 4 and 3 and running thence with the joint line of said lots, N. 46-51 E., 200 ft. to an iron pin; thence N. 43-09 W., 100 ft. to an iron pin at the joint rear corner of lots 4 and 5; thence with the joint line of said lots, S. 49-46 W., 153.5 ft. to an iron pin on the eastern side of the turn-around of Evergreen Circle; thence along the curve of said turn-around in a southerly direction 60 ft., more or less, to an iron pin on the eastern side of Evergreen Circle; thence along the side of said Circle, S. 43-09 E., 70 ft. to an iron pin at the point of beginning.
