TO ALL WHOM THESE PRESENTS MAY CONCERN: we, Lemuel B. Bradshaw and Velma C. Bradshaw

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Oneal Township, on the Southwest side of State Highway No. 14, near Washington Baptist Church, and being known and designated as lots nos. Thirteen (13) and Seventeen (17) of the Ernest Cantrell property as shown on plat prepared by H. S. Brockman, Reg. Surveyor, dated Sept. 16, 1952 and which plat has been recorded in the R. M. C. Office for said County in Plat Book CC, page 169. This being the same property which was conveyed to mortgagors herein by Nellie Florence B.
