(\$14,000,00), with interest thereon at the rate of seven (7) per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is twenty (20) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern side of Henderson Road in the City of Greenville, being shown as Lot No. 61 on plat of Section F of GOWER ESTATES recorded in the RMC Office for Greenville County, South Carolina, in Plat Book JJJ at Page 99, made by R. K. Campbell and Webb Surveying and Mapping Company in November, 1965, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Henderson Road at the joint corner of Lots Nos. 61 and 72 and running thence along the line of Lot No. 72, S. 26-23 E., 124.1 feet to an iron pin; thence along the line of iron pin on the western brive, N. 19-54 W., 135 feet to an iron pin; thence along Aldridge Drive, N. 19-54 W., 135 feet to an iron pin; thence with the curve of Aldridge Drive and Henderson Road (the chord being N. 77-02 W.) 28.5 feet to an iron pin on the southeastern side of Henderson Road; thence along Henderson Road, S. 58-05 W., 130 feet to the beginning corner.

Being the same property conveyed to the mortgagor herein by deed recorded in Deed Volume 855 at Page 173.
