NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville, in Bates Township, and having, according to plat made by Terry T. Dill, Surveyor, April, 1967, the following metes and bounds, to-wit:**

BEGINNING at an iron pin at the Southwest intersection of Little Texas Road and Bridwell Road and running thence with Little Texas Road, S 19-30 W 286 feet to an iron pin; thence N 71-22 W 300 feet to an iron pin; thence S 18-38 W 150 feet to an iron pin; thence N 71-22 W 354 feet to an iron pin; thence N 23-30 E 280.6 feet to an iron pin; thence N 36-15 E 316 feet to an iron pin at corner of other property of C. Dennis Drummond; thence S 40-15 E 178.6 feet to an iron pin; thence N 44-10 E 148 feet to an iron pin on Bridwell Road; thence with Bridwell Road, S 40-50 E 372 feet to the point of beginning.
