D. Collier by H. L. Dunahoo, Surveyor, dated October 27, 1947, and having the following courses and distances, to-wit:

BEGINNING on a stake on the south side of Davis Street, joint front corner of Lots Nos. 51 and 52, and runs thence S. 12 E. 215 feet to a stake on the right-of-way of the P. & N. Railway; thence with said right-of-way, N. 62-30 E. 52 feet and N. 67-35 E. 52 feet to a stake, corner of Lot No. 54; thence with line of that lot, N. 12 W. 190 feet to a stake on the south side of Davis Street; thence therewith S. 79 W. 100 feet to the beginning corner.
