WHEREAS, we the said Billy H. Barnette and Sara M. Barnette and Bobbie Joe Barnett and Margaret H. Barnette in and by our regular promissory note in writing of even date with these Presents, are

and truly indebted unto the Citizens Building and Loan Association, Greer, S. C., in the full and just sum of Six Thousand Eight Hundred and no/100 - - (\$ 6,800.00 ...) Dollars,

with interest from the date hereof at the rate of seven per cent (7 %) per annum, unpaid interest to

bear interest at the same rate, to be repaid in installments of

Sixty One and 13/100 - - - - - - (\$ 61.13) Dollars due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest and all costs, insurance, and expenses incurred in connection with said loan, has been paid, said monthly payments to be applied first to the payment of interest, and then to payment of principal, costs, expenses and interest due incurred; and said note further providing that if at any time any portion of the principal or interest due hereunder shall be past due and unpaid for a period of sixty (60) days, or upon failure to comply with any of the by-laws of said Association, or with any of the stipulations of this mortgage, the whole amount due under said note, shall at the option of the holder become immediately due and payable, and said note further providing for a reasonable attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and collectible as a part thereof, if the same be placed with an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind.

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, about six miles rorth of Greer, S. 'C., lying just east from State Highway No. Il and on the South side of a dirt road, being shown on plat for Bobby Joe Barnette and Margaret H. Barnette by H. S. Brockman, surveyor, dated Feb. 3, 1961, recorded in plat book WW page 39, Greenville County R. M. C. Office and having the following metes and bounds, to wit:

BECINNING on a stake in the center of said dirt road at a point N. 43-00 E., 86.5 feet from the center of intersection of Highway No. 14 and runs thence with the said dirt road N. 43-00 E., 176.6 feet to a stake in the said road; thence S. 21-15 E., 25 feet to an iron pin on the south bank of the road; thence continueing with the same course for a total distance of 264 feet to an iron pin which is 14 feet from old corner; thence a new line N. 61-30 W., 245.4 feet to the beginning corner and containing o.48 of an acre more or less.
