All that piece, parcel or lot of land in O'Neal Township, Greenville County, State of South Carolina, lying on the north side of Styles Mill Road and bounded by lands of W.T. Coleman Estates and other lands of Grantor and containing one and one half acres, more or less and having the following metes and bounds:
