To All Whom These Presents May Concern: GLYNN LINDSEY, INC.

(herein called mortgagor) SENDS GREETING:

WHEREAS, the said mortgagor, GLYNN LINDSEY, INC.

a corporation chartered under the laws of the State of South Carolina, is well and truly indebted

to the mortgagee in the full and just sum of Twenty-Four Thousand Six Hundred and No/100-----

Dollars, in and by its certain promissory note in writing, of even date herewith, due and payable

on demand

with interest from date hereof, at the rate of Seven (7)

percentum until paid; interest to be computed and paid monthly commencing six (6) months from date hereof

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of its interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including ten per cent of the indebtedness as attorney's fee, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

ALL that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot 111, on Plat of Merrifield Park, which plat is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 000, Page 177, and having, according, to said plat, the following metes and bounds, to-wit:
