(hereinafter referred to as Mortgagor) SEND(S) GREETING:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the West side of Gail Avenue, about 3 miles Northwest of Greer, in Oneal Township, and being known and designated as lot no. Forty-six (46) of Valleyhaven Acres, Section 4 as shown on plat prepared by John A. Simmons, Reg. Surveyor, dated July 15, 1960 and which plat has been recorded in the R. M. C. Office for said County in Plat Book MM, page 167. This being the same property which was conveyed to Charlton E. Miller, Jr. by W. Dennis Smith by deed recorded in the said office in Deed Book 818, page 111. And being the same property which was conveyed to mortgagor herein by Charlton E.
