

feet and N 73 W, 224 feet to the center of bridge over river; thence with East side of Gibbs Shoals Road, N 29 E, 268 feet to a stake; thence continuing with East side of Gibbs Shoals Road, N 7 E, 700 feet to the beginning containing 27 acres, more or less.

There is excluded from the above boundaries two parcels of land heretofore conveyed by Gordon Satterfield to C. D. Henson and Euline Satterfield Henson by deed recorded in the RMC Office for Greenville County in Deed Book 505, Page 551, and also conveyed by Gordon Satterfield and Charles L. Satterfield to Shelby Jean S. Gordon by deed recorded in the RMC Office for Greenville County, South Carolina in Deed Book 721, Page 125.

AND ALSO ALL that tract of land in Butler Township, Greenville County, South Carolina, shown as Lot No. 111 on Plat of Pelham Mill Village Plat No. 2, recorded in Plat Book M Pages 60 and 61, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of a county road, corner of Lot No. 110 and runs thence with said road, N 4-30 E, 100 feet to an iron pin, corner Lot No. 112; thence with line of said lot, S 71-30 W, 400 feet to an iron pin, corner of Lots 111, 112 and 113; thence with the line of Lot No. 113, S 83-23 W, 536.4 feet to an iron pin on water rights; thence with the line of said water rights, S 18-24 E, 495 feet and S 45-47 E, 124.7 feet to an iron pin at corner of Lot No. 110; thence with the line of Lot No. 110, N 37-06 E, 700.3 feet to an iron pin; thence N 69-36 E, 252 feet to the beginning and containing 5.80 acres, more or less.

AND ALSO ALL that parcel or lot of land situate on the Southwest side of a County Road and on the Northeast side of Pelham Mill Pond on the Enoree River, being shown as Lot No. 109 on Plat No. 2 of Pelham Mill Village, recorded in the RMC Office for Greenville County, South Carolina in Plat Book M, Pages 60 and 61, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest side of said County Road at the joint front corner of Lots Nos. 109 and 110, and runs thence along the line of Lot No. 110, S 69-42 W, 759 feet to an iron pin on the Northeast edge of the Pelham Mill Pond on Enoree River; thence along the edge of said river the traverse lines being as follows: S 54-48 E, 353 feet; S 64-10 E, 100 feet; and S 56-22 E, 152 feet; thence leaving said mill pond and running thence N 39-29 E, 375 feet to an iron pin; thence N 66-52 E, 158 feet to an iron pin on the Southwest side of A County Road; thence along said road, N 39-43 W, 100 feet to an iron pin; thence still along said County Road, N 33-58 W, 200 feet to an iron pin, the beginning corner.

There is expressly excluded from this boundary that lot conveyed to Cohen Satterfield by deed of Gordon Satterfield recorded in the RMC Office for Greenville County, South Carolina in Deed Book 411, Page 541, and that lot conveyed to Carl R. Smith by deed recorded in the RMC Office for Greenville County, South Carolina in Deed Book 593, Page 313.
