"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Cambridge Drive and being known and designated as Lot 12 on Plat of Brookwood, recorded in the R. M. G. Office for Greenville County in Plat Book "B B", at Page 27, and having, according to said Plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Cambridge Drive at the joint front corner of Lots Nos. 11 and 12 and running thence along the joint line of said Lots N. 2-15 E. 165 Feet to an iron pin; thence N. 37-45 W. 100 Feet to an iron pin; thence along the joint line of Lots Nos. 12 and 13 S. 2-15 W. 165 Feet to an iron pin; thence along the north side of Cambridge Drive S. 37-45 E. 100 Feet to the point of beginning.
