NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagor at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and having, according to a plat prepared by J. C. Hill April 23, 1965, the following metes and bounds, to wit:

BEGINNING at an iron in at the intersection of Hampton Avenue Extension and Monroe Street, and running thence with Hampton Avenue Extension, S. 59-10 E. 88 feet to an iron pin; thence N. 33-40 E. 120 feet to an iron pin; thence N. 59-10 W. 88 feet to an iron pin on the southeasterly side of Monroe Street; thence with said Stmet, S. 33-40 W. 120 feet to the point of beginning, and being the same property conveyed to mortgagor by Deed recorded in Deed Book 850, Page 86.
