JIM WILLIAMS, INC.,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Fifteen Thousand Two Hundred and No/100 (\$15,200.00) DOLLARS (\$ 15,200.00 ), with interest thereon at the rate of 7 3/4 % for the 1st 120 months per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is twenty(20) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown on the plat of the property known and designated as Lot No. 73 of Fairford Circle, in a subdivision of COLONIAL HILLS, Section 5, recorded in the R. M. C. Office for Greenville County in Plat Book QQQ, Page 21, and according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the southern side of Fairford Circle which iron pin is the joint front corner of Lots Nos. 72 and 73 and running thence S. 5-57 W. 176.3 feet to an iron pin; thence N. 83-56 W. 60.15 feet to an iron pin; thence N. 6-12 E. 61.1 feet to an iron pin; thence S. 75-58 W. 34.1 feet to an iron pin; thence N. 6-55 E. 128.1 feet to an iron pin on the southern side of Fairford Circle; thence along the southern side of Fairford Circle S. 83-15 E. 90.0 feet to an iron pin, the point of Beginning
