(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **FIFTEEN THOUSAND AND NO/100ths-----**

DOLLARS (\$ 15,000.00), with interest thereon from date at the rate of **Eight (8%)** per centum per annum, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, shown on plat of T. Walter Brashier recorded in the R. M. C. Office for Greenville County in Plat Book _____, page _____, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of Courtney Circle which iron pin is situate 599.8 feet East of the Old Buncombe Road and running thence N 17-21 E 183.7 feet to an iron pin; thence 68-51 E 84.5 feet to an iron pin on the Western side of Linda Lane; thence with said lane the following courses and distances, to-wit: S 9-10 W 69.1 feet to an iron pin; thence S 14-57 W 48.6 feet to an iron pin; thence S 22-55 W 70 feet to an iron pin; thence along the Northern side of Courtney Circle N 67-05 W 89.9 feet to the point of beginning and being one of the lots conveyed to me by deed of Sloan E.
