NOW, KNOW ALL MEN. That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgages at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assions:

"ALL that certain place, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot 1 on plat of Capital City Real Estate made by J. C. Hill, L. S., November 23. 1959, and recorded in Plat Book OO at page 377 in the RMC Office for Greenville County, According to said plat, the property is more fully described as follows:

BEGINNING at an iron pin at the intersection of Ghana Drive and Blassengame Road and running thence with said Blassengame Road, N. 23-15 E. 78 feet to an iron pin; thence continuing with said road, N. 32 E. 41 feet to an iron pin; thence continuing with said road, N. 46 E. 38.3 feet to an iron pin on a greater Greenville sewer district right of way; thence with said right of way, S. 70-10 E. 52.8 feet to an iron pin at the joint rear corners of Lots 1 & 2; thence with the joint line of said lots, S. 25-15 W. 150 feet to an iron pin on Ghana Drive: thence N. 74 W. 60 feet to an iron pin at the point of beginning.

TO HAVE AND TO HOLD, all and singular the said pramises unto the Mortgagee, its hairs, successors and assigns, forever.

The Mortgagor covenants that it is lowfully selzed of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumbes the same, and that the premises are free and clear of all liens and encumbrances except as provided harein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortages, fazyer, from and against the Mortgagor and all persons whomsoever fawfully claiming the same or any part thereof.
