"ALL that certain place, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northern side of the old National Highway in Chick Springs Township, being known and designated as Lot No. 32 as shown on a plat prepared by R. E. Dalton, Engineer, dated June, 1917, and revised April, 1923, entitled "Part of Property of E. M. Wharton, near Paris, South Carolina", recorded in the R. M. C. Office for Greenville County in Plat Book F at pages 206-208, and having, according to said plat, the following metes and bounds:
