Beginning at an iron pin on the southwest side of Welcome Road, corner of Lot No. 1; thence with the line of said lot S. 61-55 W. 146.6 feet to an iron pin corner of Lot No. 2; thence with eh line of said lot S. 30-33 E. 82.9 feet to an iron pin on the northwest side of Alden Court; thence with the northwest side of said street N. 61-55 E. 125 feet to an iron pin; thence with the curve of said street as it intersects with Welcome Road, the chord of which is N. 14-21 E. 33.9 feet to an iron pin on the southwest side of Welcome Road; thence with the southwest side of Welcome Road N. 32-20 W. 58 feet to the beginning corner.
