- (3) That it will keep all improvements now existing or hereafter eracled in good repair, and, in the case of a construction loan, that it will continue construction until completion without interruption, and should it fail to do so; the Mortgages may, at its option, enter upon sold premises, make whatever repairs are necessary. Including the completion of any construction work underway, and charge the expenses for your reports or the completion of such construction to the mortgage debt.

Should any legal proceedings be instituted for the foreclosure of this martgage, or should the Martgages become a party of any sulf involving this Martgage or the title of the premises described herein, or should the debt secured hereby or any part thereof be placed in the hands of any attorney at law for collection by sulf or otherwise, all costs and expenses incurred by the Martgages, and a reasonable attorney's fee, shall thereupon become due and popuble immediately or on demand, at the option of the Martgages, as a part of the debt secured hereby, and may be recovered and callected hereunder.
- (7) That the Mortgagor shall hold and enjoy the premises above conveyed until there is a default under this mortgage or in the note secured hereby. It is the true meaning of this instrument that if the Mortgagor shall fully perform all the terms, conditions, and covenants of the mortgage, and of the note secured hereby, that then this mortgage shall be utterly null and void; alterwise to remain in full force and virtue.
- (8) That the covenants herein contained shall bind, and the benefits and advantages shall inure to, the respective heirs, executors, administrators, successors and assigns, of the parties hereto. Whenever used, the singular shall include the plural, the plural its singular, and the use of any gender shall be applicable to all genders.
