All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, being known and designated as Lot No. 1 on a Plat of Fore Estates Subdivision, recorded in Plat Book BB, at Page 61, in the R.M.C.
