NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **GREENVILLE, Town of Mauldin**, known as Lot 5 on a plat of property of J. W. Whitt, made by C. O. Riddle, dated June 24, 1954, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwestern side of Sunrise Drive, at the joint front corner of Lots 4 and 5 and running thence along the line of Lot 4, N. 24-07 W., 106.6 ft. to an iron pin at the rear corner of Lot 4; thence N. 60-15 E., 80 ft. to an iron pin; thence along the line of Lot 6, S. 24-07 E., 108.1 ft. to an iron pin on the Northwestern side of Sunrise Drive; thence with said Drive, S. 61-21 W., 79.85 ft. to the point of beginning.
