designate in writing delivered or mailed to the Mortgagor, in monthly installments of One Hundred Thirty
Nine and 85/100----- Dollars (\$ 139.85), commencing on the first day of
January , 1970 , and continuing on the first day of each month thereafter until the principal and
interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and
