TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, We, JAMES SYLVESTER GARRISON and HATTIE MARIE GARRISON,

(hereinafter referred to as Mortgagor) is well and truly indebted unto Mildred T. Stanford and Frances W. Page

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of -----Two Thousand One Hundred Fifty and No/100-----

Dollars (\$ 2,150.00 ) due and payable

as stated therein,

with interest thereon from date at the rate of Eight per centum per annum, to be paid: monthly

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the southwestern side of Ladson Street, being shown and designated as Lot 1 on a plat of the Property of Parrish & Gower, said plat being recorded in the RMC Office for Greenville County, South Carolina, in Plat Book F, at Page 49, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the southwestern side of Ladson Street, joint corner of Lots 1 and 2, and running thence with the common line of said Lots S. 54-28 W. 150 feet to a point; thence N. 31-39 W. 100.5 feet to a point on the southern side of Otis Street; thence with the southern side of said Street N. 71-35 E. 150 feet to an iron pin on the southern corner of the intersection of Otis Street and Ladson Street; thence with the southwestern side of Ladson Street S. 35-32 E. 56 feet to an iron pin, the point of beginning.

This mortgage is junior in lien to that certain mortgage to Collateral Investment Company in the principal amount of \$14,150.00 recorded in the RMC Office for Greenville County, S. C., in Mortgage Book 1109, at Page 441, November 15, 1968.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
