TO ALL WHOM THESE PRESENTS MAY CONCERN:

WALLACE CELY CONSTRUCTION COMPANY

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **FOURTEEN THOUSAND SIX HUNDRED FIFTY AND NO/100ths--**

DOLLARS (\$ 14,650.00), with interest thereon from date at the rate of **EIGHT (8%)** per centum per annum, said principal and interest to be paid as therein stated and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the afore-said debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents do hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that piece, parcel or lot of land, with all improvements thereon, or hereon or constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, shown as **Lot 24, Section Two, Richmond Hills**, plat of which is recorded in the **R. M. C. Office for Greenville County in Plat Book JJJ, page 81**, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly side of Galax Drive at the joint front corner of Lots 24 and 25 and running thence with the line of said lots, **S 54-37 W 150 feet**; thence **N 35-23 W 60.4 feet** to a point on Lynchburg Drive; thence with Lynchburg Drive **N 29-15 E 141 feet** to curve at the intersection of Lynchburg Drive and Galax Drive; thence with said curve (the chord of which is **N 86-55 E) 26.9 feet** to a point on Galax Drive; thence with Galax Drive **S 35-23 E 106.7 feet** to the point of beginning and being the same conveyed to the company in Deed Book 867, at page 512.
