That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, Greer, on the Eastern side of Lanford Street and being shown as the Western part of Lot No. Fifty Three (53) and all of lot No. Fifty Four (54) on a plat of property made for W. F. and Pauline M. Shelton, by H. S. Brockman, Surveyor, dated February 15, 1954, and hes the following outside boundries according to said plat, to wit:
