TO ALL WHOM THESE PRESENTS MAY CONCERN:

ST. LUKE METHODIST CHURCH

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **NINE THOUSAND AND NO/100THS-----**

DOLLARS (\$ **9,000.00**), with interest thereon from date at the rate of **EIGHT (8%)** per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in O'Neal Township containing 3.18 acres as shown on plat of St. Luke Methodist Church recorded in the R. M. C. Office for Greenville County in Plat Book 4-8, page 97, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of Pine Log Ford Road at the corner of the cemetery property (which iron pin is situate 60 feet West of the corner of the cemetery property in the intersection of St. Luke Road and Pine Log Ford Road) and running thence S 80-08 W in Pine Log Ford Road 472.5 feet to an iron pin at the corner of Brown; thence S 13-39 E 343.2 feet to an iron pin in the Old Pine Log Ford Road; thence S 86-50 E 237.5 feet to an iron pin; thence N 4-37 W 73.5 feet to an iron pin; thence N 38-11 E 260 feet to an iron pin; thence N 2-53 W 150 feet to the point of beginning.

This is the same property described in Deed Book 458, page 437, excluding the cemetery shown on said plat.
