MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

Roy Cunningham and  
Mamie B. Cunningham

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto **Bank of Travelers Rest**

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

**One Thousand Two Hundred and no/100-----DOLLARS (\$ 1,200.00 )**,  
with interest thereon from date at the rate of **8** per centum per annum, said principal and interest to be repaid: **One year from date with interest payable semi-annually in advance**

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in **Bates Township** on the eastern side of **Tubbs Mountain Road Extension**, near the Town of **Travelers Rest** being the western portion of the tract designated as "**Roy and Mamie Cunningham**" on plat of **Ray McAlister** recorded in Plat Book **S** at page **153** and described as follows:

**BEGINNING** at a stake in the **Tubbs Mountain Road** 290 feet north from highway **253** and running thence **S. 87-45 E. 336.4** feet to a stake at the corner of **Grover C. Moody** line; thence with said line **N. 1-41 E. 198** feet to a stake; thence **N. 87-45 W. 345** feet to point in **Tubbs Mountain Road**; thence with said Road **S. 00-39 W. 198** feet to the beginning corner. **LESS, HOWEVER**, a portion of this property containing approximately **.48** acres and conveyed to **Redding** by deed recorded in Deed Book **772** at page **41**.

This property has a **20-foot** drive way across the south side for the use of the property of **Grover C. Moody**.

This is the remainder of the property originally conveyed to the mortgagors by **Ray McAlister** after the conveyance noted above and a previous conveyance to **Grover C. Moody** recorded in Deed Book **383** at page **23**.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
